About the cover: Targeting of δ -opioid receptor to surface membranes. COS-1 cells were transfected with a mouse δ -opioid receptor mutant (D128A), for which the conserved aspartate in the third membrane domain is replaced by alanine. Cells were double-labeled with fluorescein-conjugated concanavalin A to label the plasma membrane (*green*) and with an anti- δ -opioid receptor antibody followed by rhodamine-conjugated streptavidin (*red*). *Yellow* shows the region of colocalization.
