COS-1 cells were transfected with a mouse  $\delta$ -opioid receptor mutant (D128A), for which the conserved aspartate in the third membrane domain is replaced by alanine. Cells were double-labeled with fluorescein-congugated concanavalin A to label the plasma membrane (green) and with an anti- $\delta$ -opioid receptor antibody followed by rhodamine-conjugated streptavidin (red).
